INTERIM ORDER:

(To be read in continuity with earlier orders on 7.11.19, 8.1.2020, 5.2.2020, and 16.6.2021)

1. The complainant, **Trilochan Singh**, filed this RTI application dated **23.7.19** and sought **information regarding complaint UID 1608869 dated 13.7.19**, as enumerated in his RTI application. When no information was received, the Complainant filed a complaint under Section 18 of the RTI Act, 2005 to the Commission on **3.9.19**.

2. In its last order of this complaint case on 16.6.2021, a penalty of Rs. 5000/- was imposed on the respondent PIO-cum-SHO, Varunjit Singh, Police Station, Moti Nagar, Ludhiana, who remained absent without any intimation from 3 successive hearings of this complaint case. This is despite the **Show Cause Notice** issued to him vide this Commission's orders of 8.1.2020. The next hearing in this complaint case was listed on 11.8.2021. The SHO-cum-PIO, Varunjit Singh, Police Station, Moti Nagar, Ludhiana, who has since been promoted and transferred from Police Station Moti Nagar, has submitted a representation (received in the Commission on 22.7.2021) wherein he has stated that the requested information was in fact supplied to the complainant on 30.12.2019. The respondent PIO has also submitted a copy of the information given to the complainant along with a letter signed by the complainant, wherein he has confirmed receiving of information on 30.12.2019 and has stated that he could not inform the Commission about this because he got busy in some personal work.

3. In view of the above, the SHO-cum-PIO, Varunjit Singh, who is now serving as Assistant Commissioner of Police Traffic-2, at Ludhiana, has pleaded that he be exonerated from paying the penalty imposed upon him. It would however, be imprudent for this Bench to revise its own Order of 16.6.2021.
