The respondent PIO-cum-EO, Gurpal Singh, assured the Commission that the information requested in this RTI application shall be provided to the appellant within 10 days of receipt of this Order.

3. The respondent PIO also requested the Commission that he be given time to make a written submission with regard to material samples sought in this RTI application. The respondent PIO is given 10 days of receipt of this Order to make the aforesaid submission.
