2. The appellant states that no information has been provided by the respondents so far. In addition to the written reply, the PIOs are also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. They may take a note that in case they do not file their written reply and do not avail themselves of the opportunity of personal hearing on the next date, it will be presumed that they have nothing to say and the Commission will proceed ex-parte.

3. It also appears that the Public Information Officer o/o the Block Development and Panchayats Officer, Ludhiana-1 is merely working as a post office as the letters were issued by the office on 3.1.2020, 18.3.2020 and 15.9.2020 to the concerned Panchayat Secretaries regarding transfer of the RTI application under Section 6(3) of the RTI Act, 2005. Accordingly, the Public Information Officer o/o the Block Development and Panchayats Officer, Ludhiana-1 is directed to look into the matter and supply the complete information to the appellant before the next date of hearing under intimation to the Commission.
