ORDER

This order may be read with reference to the previous order dated 27.8.2020.

2. The appellant has sought the following information as per his RTI application:-

2. ਬਲਾਕ ਦੇ ਵੱਖ ਵੱਖ ਪਿੰਡਾਂ ਨੂੰ ਉਕਤ ਸਮੇਂ ਦੌਰਾਨ ਮੁਹੱਈਆ ਕਰਵਾਈਆਂ ਗਈਆਂ ਪਾਣੀ ਵਾਲੀਆਂ ਟੈਂਕੀਆਂ ਸਬੰਧੀ ਵੀ ਜਾਣਕਾਰੀ ਮੁਹੱਈਆ ਕਰਵਾਈ ਜਾਵੇ ਕਿ ਇਹ ਕਿਹੜੀ ਕਿਹੜੀ ਫਰਮ ਤੋਂ ਖਰੀਦ ਕੀਤੀਆਂ ਗਈਆਂ ਅਤੇ ਖਰੀਦ ਰਕਮ ਬਾਰੇ ਵੀ ਦੱਸਿਆ ਜਾਵੇ।”

3. The appellant has sent a message that he has received the complete information and having no objection if the case is disposed of.

4. According to the submissions of the appellant, no more action is required in this case. Therefore, the case is disposed of and closed.

ORDER

This order may be read with reference to the previous order dated 27.8.2020 vide which the case was adjourned due to administrative reasons and further adjourned to 7.10.2020.

2. The appellant has sought the following information:-

“Letter dated 4.12.2019, emails dated 4.12.2019 (7:32 PM), 25.12.2019 (10.50 AM), 8.2.2020 (11.49 AM)

Please provide certified true copy(s) of the comments/notings/proceedings made/done on receipt of our aforesaid correspondences.”

3. The appellant states that no information has been provided by the respondents so far. However, the representative of the respondents states that a letter bearing No. 15216 dated 31.5.2020 has been written to the appellant along with the annexures with regard to the information sought by the appellant. He further states that the complaint of the appellant has already been sent to the Commissioner of Police, Ludhiana vide No. 11651 dated 26.12.2020. Also a copy of the same has been sent by the representative of the respondents through whatsapp to the Commission, which is taken on record. During the course of hearing, the same has been sent to the appellant through whatsapp no. 7837600470 by the representative of the respondents. After going through the same by the appellant, he shows his satisfaction over the provided information. The appellant also states that the status in the office of the Commissioner of Police, Ludhiana may also be provided by impleading the same as party.

4. As the status of the complaint as has been sought by the appellant from the respondent authority vide his RTI application, the same has been provided by the respondent-Public Information Officer and nothing is left behind which could be supplied to him. With regard to the status of the complaint by the office of the Commissioner of Police, Ludhiana, the appellant is advised to make the application afresh in case he needs the status of the same. Accordingly, no more action is required in this case. Therefore, the case is disposed of and closed.
