1. The RTI application is dated **1.12.2020** vide which the appellant has sought **information regarding House No. 4189/1 Sarhindi Gate Patiala**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **5.2.2021** and Second Appeal was filed in the Commission on **22.3.2021** under Section 19 of the Right to Information Act, 2005. 1. The RTI application is dated **18.2.2020** vide which the appellant has sought **information regarding an application Dated 7.8.2009, 10.6.2013 etc.**, as enumerated in her RTI application.
