that the letter in this regard had also been sent to the appellant. However, the appellant particularly mentioned that the real Vibhu is no more available as she had died and the fake Vasikas/Intkal are being registered by the O/o the Tehsildar West, Ludhiana. In accordance with the Punjab RTI Rules, 2017, Ms. Vibhu D/o Sh. Davinder Kumar, S/o Late Sh. Inderpal Singh and Sh. Sukhbir Singh, S/o Sh. Joginder Singh S/o Sh. Piara Singh, were also impleaded in this case but no submissions have been received from the said third party concerned despite repeated attempts..

4. Also, the respondent-Public Information Officer placed on record a copy of the vasika entered regarding the sought information. Therefore, considering the Covid 19 pandemic, the reply given by the respondent and after going through the record available in the case file, the show cause notice issued to Sh. Raman Gupta, Public Information Officer o/o the Tehsildar (West) Ludhiana West, is hereby withdrawn.

5. Since the appellant has alleged that the real Vibhu had died and in her name fake Vasikas/Intkals are being registered, therefore, a copy of the case file is being sent to the Chief Director, Vigilance Bureau, Punjab to examine the case and take appropriate action as per law. A copy of the case file is also being **sent** to him along with this order.

Hence, the case is disposed of and closed. However, the opportunity is granted to the appellant to approach the Commission within two weeks in case he has any submissions to make.
