- 3) ਦਸਤਾਵੇਜ਼ਾਂ ਤੋਂ ਪ੍ਰਕੇਰੀਆਂ ਜਾਂਦੇ ਜੀ ਟੀ ਰੋਡ ਤੇ ਜੋ ਉਸਾਰੀਆਂ ਹੋ ਰਹੀਆਂ ਹਨ ਸੋਚਦਾ ਹੋਵਾਂ ਕਿ ਉਸ ਵਿੱਚ ਉਸਾਰੀ/ਕੰਪਲੈਕਸ ਵੱਲ ਜੋ ਨਗਰ ਪਾਸ ਕਰਵਾਏ ਗਏ ਹਨ ਉਹਨਾਂ ਦੀਆਂ ਕਾਪੀਆਂ ਅਤੇ ਵਿਚਾਰ ਵੱਲੋਂ ਕਿਸ ਅਧਿਕਾਰੀ ਨੇ ਇਸਦਾ ਨਿਰਦੇਸ਼ ਦਿੱਤਾ ਗਿਆ ਹੈ ਮੇਰੇ ਜਾ ਕੇ ਉਸ ਅਧਿਕਾਰੀ ਦਾ ਨਾਮ ਅਤੇ ਅਹੁਦਾ ਦੱਸਿਆ ਜਾਵੇ।
- 4) ਜੋ ਵਪਾਰਕ ਕੰਪਲੈਕਸ ਨੇ ਫਾਇਰ ਵਿਚਾਰ ਤੋਂ ਬੇਨ ਫੀ ਜੀ ਲਈ ਹੋਈ ਹੈ ਅਤੇ ਨਿਯਮ ਮੁਤਾਬਿਕ ਫਾਇਰ ਸੇਫਟੀ ਦੇ ਖੇਤਰ ਅਤੇ ਪਹਿਲਾ ਲਾਇਨ ਵਿਚਾਰੀਆਂ ਗਈਆਂ ਹਨ ਉਹਨਾਂ ਬਾਰੇ ਦੱਸਿਆ ਜਾਵੇ।

3. The respondent-Public Information Officer submitted the reply and the relevant portion of the same is reproduced below:-
