ORDER:

1. The RTI application is dated **29.7.2020** vide which the appellant has sought information **regarding the qualification of 26 SDOs posted in Drainage wing of the Water Resources department**, as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) on **1.10.2020**, and second appeal was filed in the Commission on **25.1.2021** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **7.7.2021**.

2. The respondent PIO is absent without intimation. The appellant is present through Video Conference Facility from Mohali. The respondent PIO has sent a number of replies to the appellant but the requested information has still not been provided. The appellant has contended that the 26 officials cited in the RTI application have been promoted on the basis of "fake degrees", which is why the respondent PIO is reluctant to provide the information requested. Notably the respondent PIO has failed to respond to this Commission's Notice. Under the circumstances, this Commission deems it fit to serve him with this Show Cause Notice.

3. The respondent PIO is herewith ordered to **SHOW CAUSE** as to why a penalty should not be imposed upon him under Section 20 (1) of RTI Act, 2005, for causing willful delay/denial of the information requested by the appellant as far back as on **29.7.2021**.
