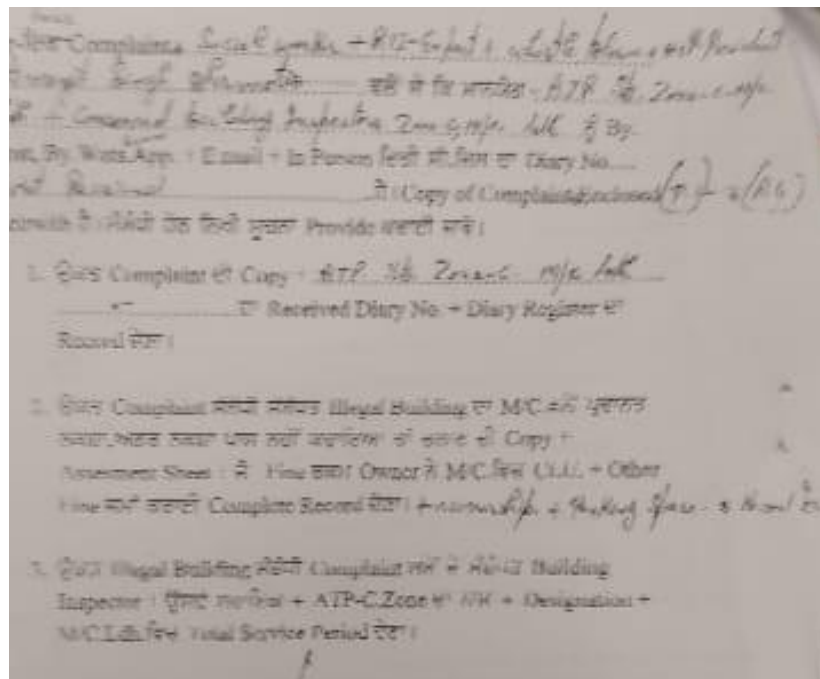

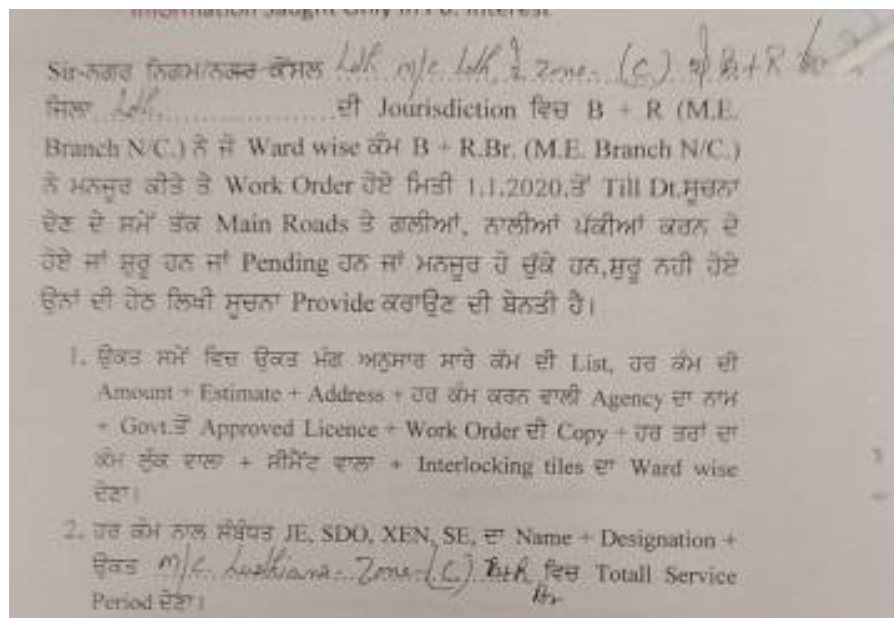

Notice was issued to the parties for first hearing in the Commission on **7.9.2022**.

2. The appellant is absent without intimation. The appellant who has preferred a number of Appeals before this Commission, has never appeared in a single case before this Bench, to date. The respondent PIO represented by Mohinder Kumar, APIO-cum-JE, has submitted a copy of reply sent to the appellant vide Letter No. 638 Dated 31.1.2022.

3. The Commission has examined the PIO's reply to the appellant and is of the view that this adequately addresses this RTI application. Furthermore, the appellant has acknowledged that he has received the information for point nos. 2 and 5 of this RTI application. Point no. 3 and 4 have been denied as "voluminous" and "not available in the format requested" by the appellant. The PIO states that this would have to be collated/created.

4. In view of the respondent PIO's reply, this Appeal Case is accordingly **Disposed of**.

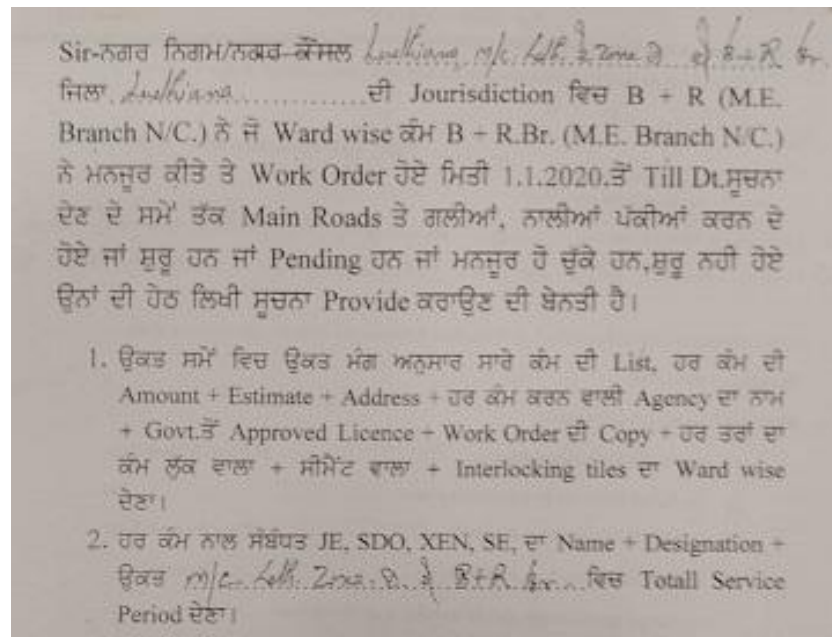
