ORDER

This order may be read with reference to the previous order dated 3.2.2022.

2. The relevant portion of the order dated 3.2.2022 is reproduced below:-

"2. Advocate on behalf of the appellant states that the sought information is in the public interest and the directions may be issued to the respondent- Public Information Officer to supply the same. However, the representative of the respondents states that the information pertaining to 1 plot has been supplied to the appellant as no response was received from the 3rd party. As far as the remaining information pertaining to 14 plots, the representative of the respondents states that the 3rd party was consulted but they have sent the written submissions that their information should not be supplied to the appellant.

3. The Punjab RTI Rules, 2017 provides as under :-

11. Procedure for deciding appeals.- The Commission, while deciding an appeal may,-

- (i) receive oral or written evidence on oath or on an affidavit from concerned or interested person;
- (ii) peruse or inspect documents, public records or copies thereof;
- (iii) inquire through authorized officer further details or facts;
- (iv) hear State Public Information Officer, State Assistant Public Information Officer or the First Appellate Authority, or such person against whose action the appeal is preferred, as the case may be;
- (v) hear third party; and
- (vi) receive evidence on affidavits from the State Public Information Officer, State Assistant Public Information Officer, First Appellate Authority, such other person against whom the appeal lies or the third party, as the case may be.

3. It is pertinent to mention the decision of the Hon'ble Supreme Court of India in Civil Appeal No. 10044 of 2010 – Central Public Information Officer, Hon'ble Supreme Court of India Vs Subhash Chandra Agarwal in which the issue regarding the exemptions under Section 8, procedure under Section 11 to be adopted by the Central Public Information Officer/State Public Information Officer has been elaborated in detail which are in line with the cases in question. The relevant portion of the judgement is reproduced below:-
"The definition of a "third party" includes a public authority. 'Third party information' is information which "relates to or has been supplied by any other person (including a public authority) other than the information applicant and has been treated as confidential by such third party. Where disclosure of 'third party information' is sought, and such information has been prima facie treated as confidential by the third party in question, the procedure under Section 11 of the RTI Act is mandatory. The Information Officer shall, within five days of receiving the request for 'third party information' notify the relevant third party to whom the information relates or which had supplied it. The notice shall invite the third party to submit reasons (in writing or orally) as to whether or not the information sought should be disclosed. Section 11(2) provides the third party with a right to make a representation against the proposed disclosure within ten days of receiving the notice. The provision expressly mandates the Information Officer to take into consideration the objections of the third party when making a decision with respect to disclosure or non-disclosure of the information. It encapsulates the fundamental idea that a party whose personal information is sought to be disclosed is afforded the opportunity to contest disclosure. The proviso to sub section (1) of Section 11 permits disclosure where the "public interest" in disclosure "outweighs" any possible harms in disclosure highlighted by the third party. Sections 8 and 11 must be read together. Other than in a case where the information applicant seeks the disclosure of information which relates to the information applicant himself, information sought that falls under the category of "personal information" within the meaning of clause (j) of Section 8(1) is also "third party information" within the ambit of Section 11, Therefore, in every case Where the information requested is "personal information" within the operation of clause (j) of sub section 1 of Section 8, the procedure of notice and objections under Section 11 must be complied with. The two provisions create a substantive system of checks and balances which seek to balance the right of the information applicant to receive information with the

right of the third party to prevent the disclosure of personal information by permitting the latter to contest the proposed disclosure."

4. Keeping in view the Punjab RTI Rules, 2017 and judicial pronouncements referred to above, the directions were given to the representative of the respondents to submit a list of relevant 3rd parties involved in this case so that the same can be impleaded as necessary party in this case in the interest of natural justice. Also the representative of the respondents assured that the list of all the parties will be submitted but till the writing of this order incomplete list has been submitted by the respondents, which is of no use.

5. Accordingly a copy of this order is being sent to the Managing Director, PSIEC to look into this matter and ensure that a list of complete 3rd parties involved in this case be sent to the Commission before the next date of hearing."

3. The representative of the respondents submits the copy of the list of 3rd parties involved in this case as per the order dated 3.2.2022, which is taken on record.

4. Viewing the attitude in dealing with the RTI application of the appellant seriously, Sh. Jaswinder Singh Randhawa, Public Information Officer, is, thus, issued a show cause notice to explain in a self-attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing wilful delay/denial of the information to the RTI application and to issue show cause for compensation to the appellant for detriment suffered by him under section 19(8) of the RTI Act, 2005.

In addition to the written reply, the PIO is also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take a note that in case he does not file
