*(To be read in continuity with earlier orders on 4.3.2021, 1.7.2021, 2.12.2021, and 10.3.2022)*

1. The RTI application is dated **1.3.2019** vide which the appellant has sought information **regarding the Greenland Kindergarten (School) in Ludhiana in ten points**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **16.4.2019**, and Second Appeal was filed in the Commission on **18.11.2020** under Section 19 of the Right to Information Act, 2005. The case was last heard on **10.3.2022**.

2. The appellant is absent without intimation. Vide this Commission's Order of 2.12.2021, the respondent PIO was given final opportunity to comply with this Commission's Order of 1.7.2021, to submit copies of the information purportedly sent to the appellant vide Letter No. 483 Dated 28.6.2021, to the Commission. "In addition to the written reply, the respondent PIO is also given an opportunity under Section 20 (1) provision there to, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him *ex parte*." Copies of this order be sent to the parties through registered post.
