## ORDER

This order may be read with reference to the previous order dated 24.9.2020.

2. The appellant has sought the following information :-  
“ਬੀ.ਡੀ.ਪੀ.ਓ. ਦਫਤਰ ਦੇਰਾਹਾ ਵਿੱਚ ਜੋ ਨਵੀਂ ਇਮਾਰਤ ਦੀ ਉਸਾਰੀ ਹੋ ਰਹੀ ਹੈ ਕ੍ਰਿਪਾ ਕਰਕੇ ਉਸ ਸਬੰਧੀ ਜਾਣਕਾਰੀ ਹੇਠ ਲਿਖੇ ਅਨੁਸਾਰ ਨੁਕਤਾ ਵਾਈਜ਼ ਜਾਣਕਾਰੀ ਮੁਹੱਈਆ ਕਰਵਾਈ ਜਾਵੇ ਜੀ:-

1. ਦਫਤਰ ਨੂੰ ਰੈਨੋਵੇਟ ਕਰਨ ਉਪਰ ਕਿੰਨਾ ਖਰਚਾ ਆਇਆ ਹੈ।
2. ਇਹ ਫੰਡ ਆਪ ਜੀ ਨੂੰ ਕਿੱਥੋਂ ਪ੍ਰਾਪਤ ਹੋਏ ਹਨ।
3. ਰੈਨੋਵੇਟ ਕਰਨ ਲਈ ਆਪ ਜੀ ਨੇ ਕਿੱਥੋਂ ਮਨਜ਼ੂਰੀ ਲਈ ਸੀ।
4. ਰੈਨੋਵੇਟ ਕਰਨ ਦਾ ਐਸਟੀਮੇਟ ਦਿੱਤਾ ਜਾਵੇ।
5. ਜੋ ਜੋ ਮਟੀਰੀਅਲ ਵਰਤੋਂ ਵਿੱਚ ਆਇਆ ਹੈ ਉਸ ਦਾ ਬਿੱਲ ਦਿੱਤਾ ਜਾਵੇ।”

3. The appellant states that he has received the complete information except a map of building approved by the Municipal Council, Doraha. He has also sent an email in this regard, which is taken on record. However, the representative of the respondents states that the appellant has not sought the same as per the RTI application.

4. According to the submissions of the parties and going through the RTI application, it has transpired that the appellant has not sought the map of building approved as per the RTI application so the request of the appellant is rejected in this regard. However, the appellant is advised that in case he wants the same information, he has to file the application afresh to the public authority concerned.

5. Since the complete information has been supplied to the appellant, therefore, the Commission observes that no further action is required in this case. Hence, the case is disposed of and closed.
