1. The RTI application is dated **6.1.2020** vide which the appellant has sought **information by way of the CCTV footage, roznamcha of CIA Staff Jagraon from 28.12.19, and summons issued on her complaints – No. 1011089 dated 29.2.16 and No. 3650PC-1 18.12.18 etc.,** as enumerated in her RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **10.1.2020** and Second Appeal was filed in the Commission on **15.1.20** under Section 19 of the Right to Information Act, 2005. If that be the case, then a copy of the Roznamcha pertaining to 28.12.2019 shall be sealed within the case file and will not be supplied to this or any other appellant in any other case. There is no further cause for action and this Appeal case is herewith **CLOSED**.
