1. The RTI application is dated **17.9.2020** vide which the appellant has sought information **regarding work orders etc.**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **20.10.2020** and Second Appeal was filed in the Commission on **15.4.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **25.11.2021**.

2. Both parties are present. At the last hearing on 25.11.2021, the respondent PIO was directed to submit ten pages of the dispatch register whereon Letter No. 3644 Dated 28.9.2020, was entered. The said pages were to include five preceeding and five succeeding pages to the page where the aforesaid letter, raising demand of Rs. 1,63,863.00 as cost of copying, was entered. The respondent PIO has in compliance with this Commission's Order, has submitted copies of the dispatch register pages vide Letter No. 7824 Dated 20.12.2021.

3. It is now established that the respondent PIO did raise the demand of Rs. 1,63,863.00 as copying charges for the requested information well within the stipulated period after the filing of this RTI application. The appellant was asked whether he is willing to deposit the copying cost as enumerated by the respondent PIO. The appellant has stating on record at this hearing that he does not possess the finances to pay the aforesaid cost.
