- 1. The RTI application is dated 13.8.2020 vide which the appellant has sought information regarding Orient Cinema in Ludhiana by way of the complete file etc., as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) on 2.9.2020 and second appeal was filed in the Commission on 24.12.2020 under Section 19 of the Right to Information Act, 2005. Notice to the parties issued for first hearing in the Commission on 9.4.2021.
- 2. Both the parties are present through Video Conference Facility from Ludhiana. The respondent PIO, represented by Rama Shankar, Clerk, failed to submit any reply to the RTI application filed on 13.8.2020. He submitted that the present owner of the Cinema cited in this RTI application has objected to the release any information pertaining to said site claiming it as "personal information". However, in this RTI application, the appellant has sought information regarding the aforesaid Cinema Hall from the date of its original allotment, which was many years before the present owners took possession of the same.
