### ORDER

This order may be read with reference to the previous order dated 21.4.2022.

2. The appellant has sought the following information:-

- (i) Copy of remarks endorsed by Divisional Commissioner Jalandhar on my email complaint dated 10.10.2020 (copy enclosed please)
- (ii) Name and designation of Enquiry Officer to whom my above complaint has been marked for investigation with the copy of letter.
- (iii) Details of action taken by Enquiry Officer on my above complaint.
- (iv) Copy of statement of Sh. Jasbir Singh ADC cum FAA taken by the Enquiry Officer on my above email complaint.
- (v) Copy of GOVT ORDERS, NOTIFICATION ISSUED BY INDIAN/PUNJAB GOVT, SECTION OF INDIAN CONSTITUTION and IPC under which Sh. Jasbir Singh ADC cum FAA had used DEFAMATORY AND INSULTING LANGUAGE in their order issued against my RTI appeal Case No 9/RTI dated 31.05.2019 (copy enclosed)
- (vi) Details of action taken by Divisional Commissioner against Sh. Jasbir Singh ADC cum FAA Jalandhar for using INSULTING AND DEFAMATORY LANGUAGE against a SENIOR CITIZEN along with copy of letters if any.
- (vii) Name and designation of officials responsible for not taking action on my email complaint dated 03.02.2020 despite the lapse of nine months along with details of action taken by Divisional Commissioner.

3. The representative of the respondents submits that the complete information has already been supplied to the appellant and nothing more is available on record, which could be supplied to him. She further submits that the appellant has also inspected the complete file and requested to close the case. However, the appellant insisted that the respondent-Public Information Officer may be directed to file an affidavit in this regard which the respondent agreed to file the same within one week.

4. Accordingly, the respondent-Public Information Officer is directed to file an affidavit that the complete information has already been supplied to the appellant and nothing more is available on record which could be supplied to him. He is also directed to send an original affidavit to the appellant with a copy to the Commission within one week. With these directions the case is disposed of and closed. However, the liberty is granted to the appellant to approach the Commission within two weeks, if he does not receive the same.

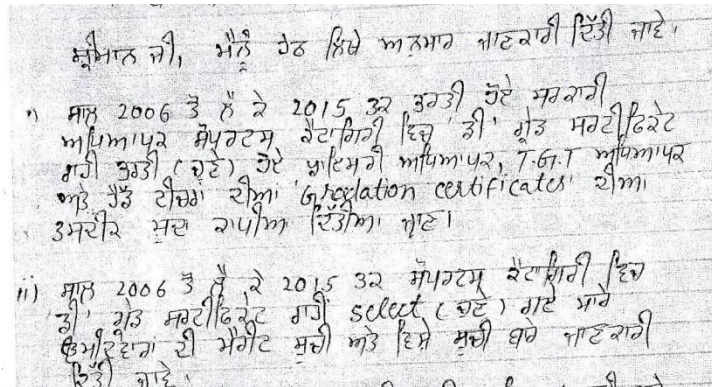
