(ii) the subject matter of which is more closely connected with the functions of another public authority,

the public authority, to which such application is made, shall transfer the application or such part of it as may be appropriate to that other public authority and inform the applicant immediately about such transfer:

Provided that the transfer of an application pursuant to this sub-section shall be made as soon as practicable but in no case later than five days from the date of receipt of the application"

It is evident from the above that the RTI application is being dealt with very casually and in non-serious manner.

8. It is also pertinent to mention that Sh. Gurprit Singh, Superintendent is presently posted in the office of Block Development and Panchayats Officer, Majri, District Mohali.

9. After going through the submissions of the representative of the respondents the Commission is of the view that the Public Information Officer o/o the Director, Rural Development & Panchayat Deptt.,Pb. be impleaded as necessary party in this case so as to take the matter to its logical end. Also the directions are issued to the Public Information Officer o/o the Director, Rural Development & Panchayat Deptt.,Pb. to look into the matter personally and file the reply/supply the information to the appellant with a copy to the Commission before the next date of hearing failing which the penalty provisions will be invoked on the next date of hearing.
