2. Both parties are present. At the last hearing on 12.4.2022, the respondent PIO was directed to submit a duly notarized affidavit. He has failed to comply and has in fact merely submitted a self attested photocopy which is not as per this Commission's direction at para no. 2 of its Order of 12.4.2022.

3. The respondent PIO represented by Dalip Soni, Building Inspector, is hereby directed to comply with para no. 2 of this Commission's Order of 12.4.2022, within 10 days. In the event of noncompliance, the appellant can approach the Commission with a request to reopen this Appeal Case where after the respondent PIO will qualify for penalties as per the RTI Act 2005.

4. This Appeal Case is accordingly **Disposed of**.
