ORDER

1. This order may be read with reference to the previous order dated 29.04.2019.
2. Appellant, Dr. Ravi Jindal is not present for today's hearing but an email dated 09.06.2019 has been received from the appellant by the bench of Ld. SIC, Dr. Pawan Kumar Singla stating that he has not received reply to point no. 7 of his RTI application.
3. On this, respondent, Ms. Gurmeet Kaur states that reply in connection with point no. 7 has already been supplied to the appellant through registered post. She presented a copy of the supplied reply during the hearing before the bench of undersigned. She submitted a copy of an email dated 14.05.2019 comprising a letter no. 35 dated 14.05.2019, signed by the Chairperson District Appropriate Authority-Cum-Civil Surgeon, Patiala along with supporting documents, which is taken on record.
4. After hearing the respondent and examining the documents placed on record, it is observed that reply through letter no. 1030-32 dated 22.05.2019 has already been supplied to the appellant along with letter no. 35 dated 14.05.2019 and supporting documents. We are of the view that supplied reply is satisfactory.

It is also observed that appellant, Dr. Ravi Jindal was absent on the previous hearings held on 01.08.2018, 12.09.2018, 18.12.2018, 13.02.2019 and 29.04.2019, due to one reason or other. As the requisite reply in connection with point no. 7 has already been supplied to the appellant and no cause of action is left. Hence, the instant appeal case is **disposed of & closed**.

ORDER

1. The above mentioned case was last heard by the Division Bench of Ld. SICs; Sh. A.S. Chanduraian and Sh. Avtar Singh Kaler dated 11.03.2019. This case file was sent to the Deputy Registrar to place it before the Hon'ble CIC for appropriate orders as Ld. SIC, Sh. A.S. Chanduraian demitted the office on 31st March 2019.

The Hon'ble Chief Information Commissioner, Sh. S.S.Channy vide Office Order dated 25.03.2019 has allocated the above mentioned case to the bench of Ld. SIC, Dr. Pawan Kumar Singla for hearing by Division Bench consisting of Ld. SIC, Dr. Pawan Kumar Singla and Ld. SIC, Sh. Avtar Singh Kaler. Accordingly the case was fixed for hearing today.

2. Appellant, Sh. Gurmeet Singh states that no information has been supplied by the respondent PIO till date.

3. Respondent, Sh. Harmesh singh states that reply has already been sent to the appellant thrice through registered post by the respondent PIO but returned to the PIO. He handed over 84 pages of requisite information along with one CD to the appellant during the hearing.

4. After hearing both the parties and examining the case file, it is observed that requisite information is voluminous in nature as RTI application of 70 pages. We are of the considered view that respondent PIO is not bound to reply each and every query of the RTI application in case of voluminous information demanded by the appellant. It is also found that most of the queries raised in RTI application are in question form.

5. The observations of the present case are that, appellant may visit the respondent's office within thirty day from today and inspect the specified record as his RTI application is voluminous in nature. Respondent PIO, O/o Tehsildar and appellant, Sh. Gurmeet Singh is advised to mutually cooperate and make sure that he inspected the specified record. Respondent PIO is directed to supply the identified pages after collecting the documentation fee against them.

6. In wake of above no further cause of action is required in this case. Therefore, the instant appeal case is **disposed of & closed**.
