## ORDER

This case has already been heard on 20.10.2020 but was reserved to be pronounced.

- The appellant has sought the following information as per his RTI application :-  
“26 ਜੂਨ 2014 ਤੋਂ 4 ਜੁਲਾਈ 2014 ਦੀਆਂ ਸਬ ਰਜਿਸਟਰਾਰ ਅੰਮ੍ਰਿਤਸਰ 2 ਦੁਬਾਰਾ ਜੋ ਰਜਿਸਟਰੀਆਂ ਕੀਤੀਆਂ ਗਈਆਂ ਸਨ ਜਿਸ ਦੀ ਪੜਤਾਲ ਐਸ.ਡੀ.ਐਮ. ਅੰਮ੍ਰਿਤਸਰ 2 ਮਿਤੀ 14.7.2014 ਨੂੰ ਮਾਨਯੋਗ ਡਿਪਟੀ ਕਮਿਸ਼ਨਰ ਜਲੰਧਰ ਨੂੰ ਸੌਂਪੀ ਸੀ ਉਕਤ ਕੀਤੀ ਗਈ ਪੜਤਾਲ ਰਿਪੋਰਟ ਦੀ ਕਾਪੀ ਦਿੱਤੀ ਜਾਵੇ।  
2. ਡਵੀਜ਼ਨ ਕਮਿਸ਼ਨਰ ਜਲੰਧਰ ਨੂੰ ਕਸੂਰਵਾਰ ਅਧਿਕਾਰੀ ਖਿਲਾਫ ਲਿਖੇ ਪੱਤਰ ਨੰ: 194243 ਮਿਤੀ 15.7.2014 ਨੂੰ ਭੇਜੇ ਗਏ ਪੱਤਰ ਦੀ ਕਾਪੀ ਅਤੇ ਉਸਤੇ ਹੋਈ ਕਾਰਵਾਈ ਰਿਪੋਰਟ ਦੀ ਕਾਪੀ ਦਿੱਤੀ ਜਾਵੇ”
- The respondents placed on record a copy of letter vide which the complete information comprising 108 pages of a file in respect of the RTI application have been supplied to the appellant, which is taken on record.
- During the hearing on 20.10.2020, the appellant agreed with the submissions of the respondents and stated that although he has received the complete information but he would like to file the submissions and accordingly, the appellant was advised to submit the same within a week.
- Till date nothing has been received from the appellant, which transpires that he is satisfied with the information so supplied to him by the respondents. Therefore, the Commission observes that no more action is required in this case and the case is disposed of and closed.
